GENERAL PROCUREMENT NOTICE

1. “Hrvatske autoceste” d.o.o. (“HAC”) has received a loan from the European Bank for Reconstruction and Development (“EBRD”) and from the European Investment Bank (“EIB”) toward the costs of the financing of construction of motorway sections along European Corridor Vc placed in Republic of Croatia.

2. All works required for the Project, which have total estimated cost of around EUR 120.000.000,00 have been already procured, including:

- Group of works I: Section Sredanci – Bosnia & Herzegovina border: route (in total length of 3,2 km);
- Group of works II: Section Sredanci – Bosnia & Herzegovina border: bridge over river SAVA, Croatian part (in total length of 0,66 km) - under preparation of the tender;
- Group of works III: Section Ploče interchange – Bosnia & Herzegovina border: border crossing “Metković” (in total length of 1,5 km);
- Group of works IV: Section Ploče interchange – Bosnia & Herzegovina border: route (in total length of 7,5 km);

3. New works that require the procurement will be tendered and will be solely financed from the loan savings from the EBRD loan. These works pertain the following:

- **Procurement of road equipment and utilities for furnishing the sub - section: Drava Bridge – Osijek Interchange**

Note: Mentioned sub - section is placed on the north part of corridor Vc, on A5 Motorway (Beli Manastir - Osijek - Svilaj), Section 2: Beli Manastir - Osijek.

4. Tendering procedure for above stated works is expected to begin in August/September 2015;

5. Contract to be financed with the proceeds of a loan from the EBRD will be subject to the EBRD's “*Procurement Policies and Rules*” (issue October 2014) and will be opened to firms from any country. The proceeds of the loan will not be used for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations or under a law of official regulation of the Purchaser's country.
